We'll have two days to tour the park before moving on to Bryce Canyon and Lake Powell. Once at the Lake Powell resort, we'll get our feet wet on a boat tour. Day two will find us back on the water for an afternoon float trip down the Colorado River in Glen Canyon. Optional air flights over the area are available, we'll enjoy some local food and shopping and return home via Las Vegas on Sunday or Monday depending on your available flight schedule. 

#### CONDITIONS

**Reservations & Payment:** You are encouraged to mail your reservation without delay. Reservations will be confirmed by American Travel Association (ATA) upon receipt of the Reservation Form and a \$250 per person deposit. Receipt of final payment is due in the office of ATA no later than August 2. All payments must be made by check payable to American Travel Association or by Visa, MasterCard, Discover or American Express Card.

**Cancellation**: Cancellations must be made in writing to ATA. To avoid discrepancies, ATA will not act on information given over the phone until written notice has been received.

<u>Land Package</u>: A \$50 per person cancellation fee will be charged on cancellations regardless of the reason. Penalty on cancellations received between August 2 and departure will be a maximum of 100% of the land cost per person, depending upon the amount recoverable from the suppliers to whom payment had been sent. Cancellation penalties are required to offset non-refundable hotel and supplier payments made by ATA in advance of the tour. There will be no refund for unused services once the tour has begun.

Insurance: Trip cancellation insurance can be obtained from Allianz <a href="www.allianztravelinsurance.com">www.allianztravelinsurance.com</a> either on- line or over the phone (800-284-8300). Trip cancellation insurance is a good idea because it offsets non-refundable air, hotel, and operator charges. Please note the Pre-Existing Conditions Exclusion in the Medical Conditions section. If one exists, you need to purchase the insurance within 14 days of your first payment. Also check with your insurance agent to see what is covered under your existing homeowners and medical policies. For example, suitcases and contents are probably covered under your homeowner's.

**Prices**: This price is subject to change due to cost increases, and in number of participants upon which the tour cost is based (14). ATA reserves the right to increase the price for such reasons. All prices are based on rates and tariffs in effect on June 12, 2019.

**Health:** The Participant represents that neither he nor she nor anyone traveling with him or her has any physical or other

condition or disability that could create a hazard to him-or-herself or other members of the tour. This program involves walking over uneven surfaces and climbing stairs at locations
